Terms and Conditions

1. **Payment:** A minimum 10% Deposit is required for all bookings, 20% for bookings in excess of \$500. With the balance due before or upon arrival on the day of the event. Accepted methods of payment include cheques in advance, EFT, Card or Cash. If paying in cash please ensure you have correct change as not all drivers will carry money. All Payments are non refundable, unless determined by Victorian Amusements staff.
2. **Cancellation Policy:** Victorian Amusements will always do what we can to minimise costs when events are cancelled, it is important you notify us as soon as possible. When close to the event date it must be via phone on 0402 131 609.
 - **Backyard hires** are not subject to any cancellation fees as long as we are notified before arriving on the day. Any deposit paid can be used towards a future booking, if we are given at least 24hrs notice.
 - **Other Refunds** are at the discretion of Victorian Amusements Pty Ltd.
 - **Event bookings** are often made well in advance so rebooking the equipment to another client may prove impossible, we will endeavour to reschedule to another date if possible. We will refund your deposit if we are notified of cancelation within 7 days of the invoice date. If you wish to postpone your event due to weather we must be notified at least 24 hours prior, your deposit can be used for another event within 6 months, subject to availability.

50% of the invoice amount is required if cancelled with two weeks of the event date and 100% if notified within 72 hours of the event.

3. **Booking Confirmation:** Bookings are not confirmed until deposit is received. Payment of deposit is deemed acceptance of terms and conditions.
4. **Access:** All Victorian Amusements staff and contractors shall be given sufficient time and adequate access for set up and pack up at the agreed upon time. Extra charges may apply for an early bump in/late bump out.
 - All Backyard Hire drop off times are approximate. If a specific time is required please contact the office in advance.
 - If no one is on site to accept delivery or we cannot gain access, extra charges may apply (charged at a reasonable rate) to cover extra staffing expenses and/or motor vehicle expenses in waiting for access or returning to the site at a later time. This also applies to picking up equipment.
 - It is the responsibility of the client and anyone acting on their behalf to provide a safe workplace for all staff.
 - The client must provide sufficient access to the set up location; all stairs and gates less than 1M must be discussed when booking. Minimum access space for specific items can be viewed on our website or by contacting the office. It is also the responsibility of the client to ensure there is efficient clean space to set up equipment. Keep in mind not just floor space but height as trees and branches can be an issue.
 - If there is not sufficient access space, obstacles in the way or not enough space to set up without damaging our equipment our staff reserve the right to cancel the booking with a full hire fee applicable.
 - Victorian Amusements cannot be held responsible for any damage incurred to property due to insufficient access space. We take no responsibility to damage to any ground surface including underground pipes/sprinklers etc.
 - It is agreed that any person signing on the clients behalf has the authority to do so.

4. Unsafe Operation Conditions:

- If Victorian Amusement staff deem the conditions unsafe for operation i.e High Winds the full hire fee still applies.
- The Hirer is responsible for providing a safe work space and ensuring all rules and instructions are observed at all times. This is for the safety of operators and users if there is not sufficient security on site Victorian amusements reserve the right to shut down the amusement.

5. Electricity: It is the client's responsibility to ensure that there is adequate access to electricity to run the equipment hired. Power points are needed within 20 metres of set up location, keep in mind if

multiple blowers or items are hired multiple circuits may need to be accessed. Victorian Amusements take no responsibility if set up cannot occur or is delayed due to lack of power. We have generators available for an extra fee, if you choose to hire a generator independently we take no responsibility if they don't power our equipment and the full hire fee still applies. To discuss your individual power needs get in touch with our office.

6. Set up surface for inflatables: grass is the safest option for the set up of inflatables so they can be pegged in. Weights can be used or fixed structures to secure the inflatables if we are given prior notice. If we get to your location and set up is on a hard surface without prior notice an extra fee may apply. In the event of strong winds Victorian Amusements staff may decide its not safe for operation in order to comply with Australian Standards and Manufacturer instructions.

7. Possible Extra Costs:

- Any costs associated with a site induction will be passed on to the hirer
- The cost of Engineer or electrical inspections requested by the hirer or venue will be passed on to the hirer
- Any parking fees incurred by Victorian amusements will be passed on to the hirer.
- Our pricing is based on the use of metal pegs, if set up is on a hard surface or we are not allowed to peg into the grass a fee for weights will apply.
- If an early bump in or late bump out is required additional fees may apply
